Residents pay a percentage of adjusted income for rent, usually 30%. Some residents pay more than 30% based on their income. Subsidy is provided by USDA Rural Development Rental Assistance; Micheal Striar Apartments are situated close to stores, schools, and public transportation. There is no management office on site.


