We do ask that your group arrive promptly. Weekend bookings are the most popular with multiple groups being booked

daily, if the group is running 15 or more minutes late, the tasting and/or tour may have to be shortened at the discretion of the

tour guide based on the day's schedule. No discounts are afforded for tardy arrivals. Please try and keep your group on time.

Payment is expected on the day of the tour prior to **starting** the event. Credit cards, cash and checks are accepted. Checks can be made payable to Flag Hill Winery. For those presenting gift certificates, please be sure to bring your gift

certificate with you, otherwise the group will be expected to pay according to the pricing above. Please be aware that some

business, educational and corporate credit card accounts have flags on them for alcohol related businesses, if paying with a credit

card, please be sure in advance that there will be no issues with this.

Tour: Winery, Distillery & Vineyard Tour

Please allow ~30 minutes for the tour, ~30 minutes for the tasting and between 15-30 additional minutes for store browsing and

purchases. If you prefer/need an abbreviated time allotment for your group's schedule, we are happy to work with you on that.

Please discuss this with us in advance based on the needs/interests of your group.

Additional Information and Instructions:

a. Please be aware that during seasonal availability the vineyard tour includes a walk to the edge of the vineyard dependent on weather issues. Please dress in appropriate clothing and footwear. Those choosing not to walk outside or unable to may remain indoors or visit the gift store during this portion of the tour. Please be aware that during the winter season or severe inclement weather, wheelchair access to the wine cellar is unavailable.

b. Please relay final group number to Flag Hill by 5/20/16, noting that last minute add-ons are not a problem, but we would be appreciative if you could call or email beforehand with as much new information as you have. Please contact Kristen Symonds with final numbers, contact information below.

c. Guests must be at least 21 to participate in the wine tasting. Flag Hill will abide by all NH State Liquor laws and may require identification from guests who may appear to be 30 or under. There is no age limitation to participate in the tour and listen to the wine discussion during the tasting (a non-alcohol drink will be provided to enjoy during the tasting).

d. No outside alcoholic beverage will be permitted on the premises facilities as part of the tasting and tour.

e. Please note that due to our NH state health license for our catering facility, no outside food is allowed to be brought in for offering to your guests.

f. Directions to Flag Hill can be found on our web site on the "Visiting" page at www.flaghill.com. We highly suggest reading these directions as we have found many car GPS devices and online mapping programs will get you to the area correctly, but not necessarily to the correct street.

g. There is no charge for the tasting and tour for the group leader for tour groups with 25 or more guests. The bus driver is also invited to take the tour and sit during the tasting (with a non alcohol beverage) at no charge should you wish to invite them.
