EFFECTIVE March 15, 2016

Pursuant to M.G.L. c. 111 § 31 and all other Massachusetts enabling statutes authorizing Boards of Health to set fees for licenses, permits and services, the New Bedford Board at their regularly scheduled meeting on March 15, 2016 voted unanimously to amend its fee schedule and hereby endorses and promulgates the following fee structure effective March 15, 2016. All permits, licenses and variances once issued are Non-Transferable by owner or location.
