1. Call to order:

D. Henry called the meeting to order at 6:03 p.m., confirming a quorum. The Chair indicated that A. Louro would serve in the City of New Bedford Planner position and J. Lopes would serve in the local organization position for K. Cox.

2. Approval of minutes:

A motion to approve the minutes of the 02.03.14 meeting was moved by B. King and seconded by J. Lopes. All voted in favor and the motion passed unanimously. A motion to approve the minutes of the 02.24.14 meeting was moved by C. Pacheco and seconded by A. Louro. All voted in favor and the motion passed unanimously.

3. Public Hearings:

60 North Water Street...new signage

A motion to reopen the public hearing was moved by A. Louro and seconded by B. King. All voted in favor and the motion passed unanimously.

NBHC members discussed how the new signage could be placed on the streetlamps. NBHC staff will also contact the Traffic Commission regarding signage in the district. Discussion on how to distinguish "No Parking" on a private way. Concern about enforcement when there are visitors to the district who do not know that the street is a private way.

1116 Chaffee Street...demolition request

Joe De Sousa, 97 Moser Street, Dartmouth, MA presented the application for the demolition of 1116 Chaffee Street to build three new residences. The house sits on two lots, one on Chaffee Street, the second on Oswald Street, which is a paper street. House has structural problems, rot, termites, and water damage. A. Louro spoke on the historical and architectural context of the property. Built in 1921, it has morphed into a 1950s ranch style. There is no atypical context to distinguish it from others in the neighborhood. The property was constructed by a French Canadian entrepreneur in the north end of New Bedford. The builder never lived in the house; it was built for speculative purposes. This was part of a planned development of the far North End. The new houses will be 1600 square feet.

A motion to open the public hearing was moved by B. King and seconded by C. Pacheco. All voted in favor and the motion passed unanimously.

177 Cove Street – A. Louro reported that demolition was on City Council agenda but it was put on the Appointments and Briefings calendar. That date has not yet been set.

NBHC staff mentioned that the Rotch-Jones-Duff House came for a letter of support for the MA Cultural Facilities Fund. A. Louro reported that there are five entities applying for that grant program – First Baptist Church, Your Theater, New Bedford Port Society (Mariner's Home), Gallery X, Rotch-Jones-Duff House and may request letters of support this week.

A. Louro has received Section 106 letters that requires responses with respect to sidewalk and road improvements on Kings Highway and Coggeshall Street.
