In accordance with **Chapter 138, s10A of the Massachusetts General Laws**, relative to the granting of licenses for the sale of alcoholic beverages, we are pleased to submit herewith a full report of the actions of the New Bedford Licensing Board for the year **2010**.

There were a total of **180** liquor licenses granted as renewals for the year **2011**.

There were **two (2)** licenses that were not renewed for **2011**:

- Merchant Mariner’s Social Club, Inc. (Club AA) - Licensee Decision
(Note: Special Legislation License---Non- Transferrable)
- West End Grill, LLC (CV W & M) – Licensee Decision
(Note: Under Quota License --- Will Be Re-Issued)

There was **1** Seasonal license granted as a renewal in **2010**. (**MWTP, Restaurant Ventures, Inc. d/b/a Davy’s Tiki Bar** – Lic. #214) - **Note:** Licensee plans to renew license in **2011**.
