In accordance with **Chapter 138, s10A of the Massachusetts General Laws**, relative to the granting of licenses for the sale of alcoholic beverages, we are pleased to submit herewith a full report of the actions of the New Bedford Licensing Board for the year **2011**.

There were a total of **182** liquor licenses granted as renewals for the year **2012**.

There was **1** **New Retail Package Store Wine & Malt only license** granted in 2011 and was renewed for **2012**. (**Crush Beverages Company, Inc. d/b/a Crush Fine Wines – Lic. #221**)

There was **1** **New Common Victualler (Restaurant) Wine & Malt only license** granted in 2011 and was renewed for **2012**. (**Spicy Lime, Inc. d/b/a Spicy Lime Thai Cuisine – Lic. #219**)

There was **1** **New Farmer-Winery Pouring Permit** granted in 2011 and was renewed for **2012**. (**Travessia, LLC d/b/a Travessia – Lic. #220**) – **Note: Permit Not Included In the 182 Total**

There was **1** Seasonal license granted as a renewal in **2011**. (**MWTP, Restaurant Ventures, Inc. d/b/a Davy’s Tiki Bar – Lic. #214**) - **Note: Licensee plans to renew license in 2012.**
