The City of New Bedford, Purchasing Department, in conjunction with the Department of Public Infrastructure is soliciting bids for the Acquisition of a new Prefabricated Membrane Covered Structure (Salt Shed).

Sealed bids must be received by the Purchasing Department, in the office of the Purchasing Agent, Room 208, City Hall, 133 William Street, New Bedford, Massachusetts, 02740, **no later than 2:00 p.m. Thursday, July 9, 2015.**

Contract Documents, including the Information for Bidders, Form of Bid, Form of Contract, Specifications, and other Contract Documents, may be obtained and/or examined on or after **Wednesday, June 3, 2015**, in the office of City of New Bedford, Purchasing Department, 133 William Street, Room 208, New Bedford, MA 02740, (Monday thru Friday – 8:30 AM – 4:00 PM) Documents may also be obtained by emailing debra.travers@newbedford-ma.gov or holly.loiselle@newbedford-ma.gov

Offerors must be certified by the Division of Capital Asset Management (DCAMM) in Modular/Prefabrication. Furthermore, all bidders must submit a **Certificate of Eligibility and update statement** along with their bid. Any bid submitted without the appropriate certificate shall be invalid.

A **Mandatory** Pre-Bid will be held on Tuesday, June 16, 2015 @ 9:00 a.m. at Dept of Public Infrastructure, 1105 Shawmut Avenue, New Bedford, MA 02746. Bids will not be accepted by those not in attendance.

Payment of Prevailing Wages, shall not apply to the manufacture of modular buildings procured pursuant to this section, but shall apply to all work ordinarily and customarily performed on modular buildings at building sites, including, but not limited to, construction of foundations, attachment to external utilities, and installation and assembly of modular unit, including any assembly performed at any site in the commonwealth other than a place of manufacture. All applicable provisions of building codes and other laws shall apply thereto.

Attention is called to the fact that supplies furnished as part of this Contract are exempt from the Sales and Use Tax. All bids submitted should take this factor into consideration, and be calculated accordingly.

The contract will be awarded within thirty (30) days after the bid opening. The time for award may be extended by mutual agreement between the City and the awarded bidder.

No Bidder may withdraw his/her bid for a period of thirty (30) days, excluding Saturdays, Sundays, and legal holidays, after the actual date of the opening thereof.

The Bidder **must** furnish a Non-Collusion Form and Statement of Taxes, with their bid.

Proposals **must** include **ALL DOCUMENTS** required by the Invitation for Bid. The Awarding Authority reserves the right to waive any informality, reject any or all proposals, or accept other than the lowest priced proposal.
